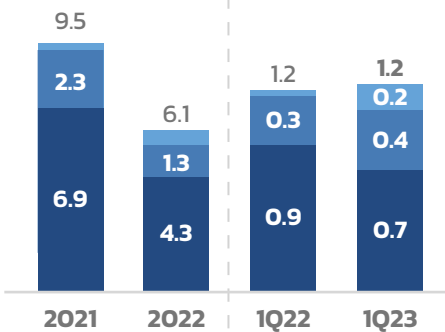

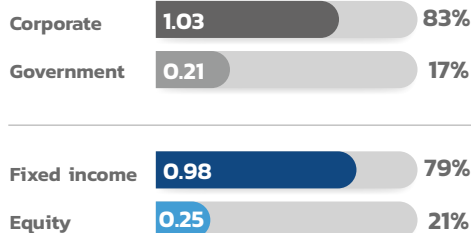
### Composition 2023

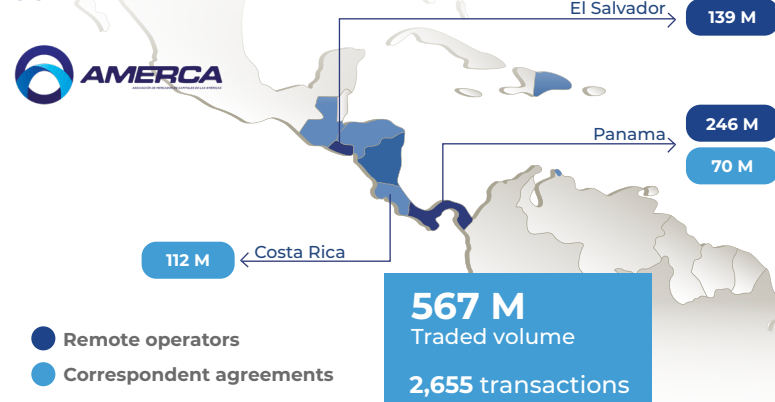

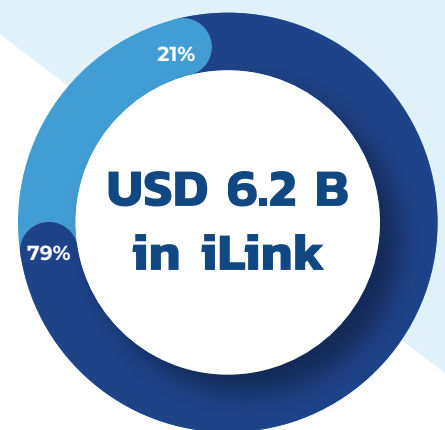
